#### 1. Introduction:

The Authority of Nalbari Medical College & Hospital, Nalbari, Assam invites sealed techno-financial bids from reputed companies/firms/suppliers for the supply, installation and commission of Video Conferencing Sysytem (VCS) for MEU Department and Face Based Bio-metric System (FBBS), for Students of NMC&H, Nalbari.

#### Scope of Work: 1.1.

- a) The Bidder is required to supply, install and commission the VC System (PTZ Camera, Interactive Display, Mice and Speaker ) and Face Based Bio-Metric Machine (FBBS) at Medical Education Unit, NMC&H, Nalbari as per NMC guideline.
- b) The bidders are advised to survey the mentioned sites before quoting bid in
- c) The successful bidder shall give comprehensive hands on Training to concerned / designated staff of Nalbari Medical College & Hospital, Nalbari, Assam on operation, preventive maintenance, recording and retrieval of the VC
- d) Workmanship and material used should be of ISI quality and cameras with 4K
- e) Bids shall be considered only in those cases where the bidder has quoted for the entire scope of the works.

# 2. Eligibility Criteria for Bidders:

# 2.1 Minimum Eligibility Criteria:

- The Company/Firm/Supplier must submit the certificate of incorporation / registration or Declaration as Proprietorship (as Annexure-II) as a part of technical bid.
- The bidding company/firm must be with a minimum consolidation turnover of Rs. 5 lakh each in the last three financial years i.e 2020-21, 2021-22 & 2022-23. Certificate of Chartered Accountant about Annual Turnover of the bidder during past three financial years (as Annexure -III ).
- The Company must have execution /experience of works related to VC System in Govt. Sector (order copies / performance certificate is to be attached).
- The bidders must have at least one registered office in the state of Assam. Documentary proof of having one registered office in the state of Assam must be submitted.
- GST Registration Certificate & up-to-date GST Return.
- Up-to-date Trade License from competent authority. e) f)
- Copy of PAN Card. g)

- h) The bidder should have valid authorization from the principal manufacturer/distributor.
- 2.2 The bidder must not be debarred or blacklisted by any state or central Govt. Department to do business with state or central Department or its Autonomous bodies. The bidder must enclose undertaking to this effect (as annexure-II)
- 2.3 Warranty on products should be of 1 year or more.
- 2.4 Complaint should be attended within 24 hours after service call.

#### 3. Bid Procedures:

#### 3.1 Instructions to bidders:

The Tender Document can be downloaded from the website i.e nalbarimcassam.org and the bidders are required to submit the tender fee of Rs. 1000/-( Rupees One thousand ) only through Demand draft along with the Tender Documents. Tenders Submitted without cost of tender form and EMD shall be rejected.

#### Submission of Bids:

Sealed offers prepared in accordance with the procedures enumerated should be submitted to the Principal cum Chief Superintendent, Nalbari Medical College & Hospital, Nalbari, Assam on or before the last date i.e upto 12.00pm on 19/03/2024.

#### **Opening of Technical Bids:**

At 2.00 pm on 19/03/2024

The bidders or their authorized representatives may be present if they so desire.

#### Advice to the Bidders:

Bidders are advised to study this Tender documents carefully before participating. It shall be deemed that submission of Bid by the bidder have been done after their careful study and examination of the Tender documents with full understanding to its implications.

#### Earnest Money Deposit (EMD):

All bidders are required to deposit EARNEST MONEY of Rs. 15,000/-(Rupees Fifteen thousand) only in the form of Demand Draft/Banker Cheque, in favour of "HMS Nalbari Medical College and Hospital," Nalbari with the bid. Exemption from EMD is allowable as per Govt. instruction. However, appropriate document to be submitted for such exemption, along with bid documents

The bids received without required Earnest Money or without exemption document shall be rejected without further reference. No interest shall be payable by Nalbari Medical College & Hospital, Nalbari, Assam on the Earnest Money Deposited by Bidder.

The successful bidder will have to deposit 2% of the final order value as the Performance guarantee at the Nalbari Medical College & Hospital, Nalbari, Assam for the warranty period.

## Period of Validity of Offer:

Offer should remain valid for 365 days after the date of opening of the Pre Qualification –cum- Technical bid as prescribed by Nalbari Medical College , Nalbari if validity of the offer is required to be extended , the validity of EMD will also have to be extended . An offer valid for a shorter period may be rejected by the authority of Nalbari Medicinal College & Hospital, Nalbari ,Assam as non – responsive.

# 3.2. Procedure for Submission of Bid:

The Bids should be submitted in two Parts i.e Technical Bid and Financial Bid.

**Technical Bid:** The Technical Bid should be put in a single sealed cover super scribing the wordings "Technical Bid" for the supply, installation and commissioning of VC System (as per NMC requirement) at MEU Department of Nalbari Medical College & Hospital, Nalbari, Assam, The EMD (Demand Draft or Banker Cheque) must be enclosed with the technical bid.

Please note that prices should not be indicated in the Technical Bid and if price found quoted, the bid will be summarily rejected.

Financial Bid: Financial Bid should be put in a single sealed cover super scribing the wording "Financial Bid" the supply, installation and commissioning of VC system (as power NMC requirement) at MEU Department of Nalbari Medical College & Hospital, Nalbari, Assam.

Financial Bid should only indicate prices filled as per BOQ provide in the Tender Document.

The Technical Bid Cover and Financial Bid Cover prepared as above are to be kept in a single sealed cover superscribed with the wording "Technical and Financial Bids" for the supply, installation and commission of VCS and FBBS (Face Based Bio-metric System), NMC&H, Nalbari.

Only authorized person should sign the tender/quotation. His name, designation and address should be given in capital letters.

No tender will be considered unless and until all the documents are properly signed and all correction must also be signed by the renderer(s)

#### **Evaluation of Bids:**

An Evaluation Committee consisting of Officers from Nalbari Medical College & Hospital, Nalbari, Assam will evaluate the bids of all the bidders, both technically and commercially as per the following schedule/ pattern.

- 1. Only Technical Bid shall be opened on the day of opening of the bids at 2.00 pm on 19/03/2024 in the presence of bidder's representative who which to attend at their cost. The bidder's representatives who are present will be required to put their sign in attendance register/document study statement of technical bids.
- 2. Conditional bids shall be summarily rejected.
- 3. The technical Bid documents shall be evaluated as per the following:
  - i. The documentation furnished by the bidder will be examined to see whether the qualifications and specific requirements including technical mentioned in the documents are fulfilled.
  - ii. The bidders, if required shall make a presentation/ demonstration of the VC system, if required, to the evaluation committee.
  - iii. The Authority of Nalbari Medical College & Hospital, Nalbari, Assam may ask bidders to arrange visits of Evaluation Committee to the departments/ organization where the bidder has already executed such order as claimed in their bid.
  - iv. The Evaluation Committee reserves the right to reject any tender bid without assigning any specific reason to the bidders.

The Financial Bid of those bidders who satisfy the parameters laid out in the Technical Bid will only be opened. The place, date and time of the opening of the Financial Bid shall be notified separately.

The bidder is expected to examine all the instructions, forms, terms & conditions and specifications in the Tender documents. Further to furnish all the information required in the tender document or submission of a bid in every respect will be at bidders risk and may result in rejection of the bid.

4. 01 (one) year onsite comprehensive warranty/guarantee including service shall be applicable to the supplied goods.

5. Payment shall be made after satisfactory installation of systems and proper functioning.

- 6. In case of malfunctioning of equipments, the same will be replaced by the successful bidder at his own cost.
- 7. Subletting will not be permitted.
- 8. Bids once submitted cannot be withdrawn/altered or modified. The bids shall remain valid and open for acceptance for a period of 365 days from the date of opening of the Technical Bids or for a period as mutually agreed upon. The EMD of any bidder, who fails to abide by the above conditions will be forfeited.
- 9. The authority of Nalbari Medical College & Hospital, Nalbari, Assam reserves the rights to demand any supporting documents from the bidder in the interest of the Institute after the opening of Technical bid. In case bidder has failed to submit the requisite documents, the price bid of that bidder will not be opened & rejected summarily.
